### Understanding Public Measure G

Public Measure G = \$220,000,000 Bond

(that means you will also pay interest)

### Reason #1 to VOTE NO:

This \$220 million bond will increase your property taxes by:

\$2.70 per \$1,000 of the taxable assessed value.

### Example:

A property assessed at \$200,000 will cost the homeowner

an additional \$290 per year.

### Reason #2 to VOTE NO:

You will be paying MILLIONS just in interest alone.

### Reason #3 to VOTE NO:

You have not been told how many YEARS you will be paying for it.

### FACT:

your tax increase will likely be permanent!

### Reason #4 to VOTE NO:

This is your

LAST CHANCE

to have any say on

The Master Facility Plan

### Reason #5 to VOTE NO:

The Master Facility Plan = *eliminates neighborhood schools.*

2023 GO Bond = \$220 Million (proposed vote Nov. 2023)

\$2.70 Levy Rate Increase

SAVE = \$20 Million PPEL = \$45 Million



### Reason #6 to VOTE NO:

If this passes = IN 6 YEARS

the District will be coming back for an <u>ADDITIONAL</u> \$250,000,000 bond from you for the Master Facilities Plan – phase 2.

### Reason #7 to VOTE NO:

Approving this bond means you approve of second bond and PPEL extension.

Continuation of \$2.70 Levy

SAVE = \$189 Million PPEL = \$129 Million

### Reason #9 to VOTE NO:




Your children will still be paying for the bond and interest.

### Our students don't need huge fancy warehouse schools!


### Warehouse Schools Are the opposite of what our kids need!



#### Kids need:

- Individualized attention
- \* Better student-teacher ratios
- Sense of community
- More opportunity to participate in extracurricular activities (bussing decreases or eliminates)
- Decreased environment for bullying

### Reason #12 to VOTE NO:

The district does not need this bond!

### FACT:

The Cedar Rapids School District already gets <u>plenty</u> of *your taxes* for infrastructure from:

PPEL Fund (\$1.34 per \$1,000 property tax levy)
 SAVE Fund (1% state sales tax)

### Reason #13 to VOTE NO:

The district does not need this bond!

1) PPEL (Physical Plant and Equipment Levy):

The Cedar Rapids School District already receives \$9 million annually from the PPEL.

The district does not need this bond!

For 50 years, you have been paying PPEL.

You are currently paying \$1.67 per \$1,000 taxable assessed value.

This property tax was sold to the voters as:

"PPEL funds support the <u>maintenance and upkeep</u> of the District's 425 acres of grounds and 2.7 million square feet of building space and have been focused on urgently-needed maintenance, with planned equipment purchases and <u>facility repairs</u>; building equipment maintenance and repair (roofing and masonry); and campus parking lots and asphalt for playgrounds."

PPEL funds are also supposed to be spent on:

"Projects that provide for <u>safe and secure schools</u>

for students and staff,

... increased <u>energy conservation efforts</u>."

The district does not need this bond!

Next year the District will be asking you to EXTEND \$1.34 of PPEL for 10 Years per \$1,000 taxable assessed value.

### Reason #14 to VOTE NO:

Instead, the District has allowed certain schools to deteriorate, then claim they're too costly to repair.

### Reason #15 to VOTE NO:

The district does not need this bond!

### (2) SAVE:

The Cedar Rapids School District already receives \$21 million annually from the Secure an Advanced Vision for Education Fund (SAVE) Fund.

The district does not need this bond!

This State fund was created in 2008.

(It is the \$0.01 sales tax we pay to the State.)

It is purposed mainly for <u>infrastructure</u>, as is <u>PPEL</u> and <u>Public Measure G</u>.

The district does not need this bond!

### SAVE's goal is:


to ensure quality school buildings and help students enter the workforce.

Activities include: the construction, reconstruction, repair, demolition, and remodeling of schools, stadiums, gyms, and bus garages, and the procurement of school sites and site improvements.

### Reason #16 to VOTE NO:

The district does not need this bond!

According to FY 2022, the District received from SAVE and PPEL...\$32 Million
